SUBJECT: Agenda Item 6 - Public Comment

Dear Mayor and City Council Members:

Whittier's City election is seven weeks from today. Mayor Vinatieri, who's been on the City Council for twenty years, the last 10 years as citywide Mayor, is again seeking re-election. A cloud of controversy hangs over his re-election campaign due to a statewide investigation of Conflict of Interest against him that is under active investigation by the State of California's Fair Political Practice's Commission, Case No: 2024-00927. The Chief of the FPPC's Enforcement Division found sufficient, videotaped evidence substantiating the sworn complaint against Mayor Vinatieri to open an investigation on Sept. 10, 2024. That was 17 months ago. Last month, I spoke before the State's FPPC Commissioners asking them to complete their investigation prior to Whittier's April 14th election. That would help inform voters in making their decision about who our next Mayor should be.

The FPPC sworn complaint includes videotape of Mayor Vinatieri voting on several City Council agenda items on the \$20 million Uptown Greenleaf Promenade Project despite being legally required to recuse himself from voting because he owns a restaurant located within the Uptown project area. As everyone knows, the City Council approved a controversial design for the Greenleaf Av Project that calls for chopping down **ALL** of the shady tree canopy on three blocks of Greenleaf Av in the heart of Uptown Whittier. Public outrage exploded over this controversial decision and has continued to intensify – the Petition to Save our Uptown Trees now has 8,148 signatures on it.

The ongoing Uptown tree controversy, and the City Council's recent action chopping down 178 beautiful, mature trees at Parnell Park to build soccer fields - when they could have signed joint use agreements with schools to use their existing soccer fields on weekends as other cities do - are among the key issues in Whittier's upcoming election. All registered voters will receive ballots in the mail starting on March 16th – that's only three weeks away.

www.SaveOurTreesWhittier.com has endorsed three HIGHLY-QUALIFIED candidates: James Becerra for Mayor, whose expertise and education credentials in Urban Planning will bring great value, Vicky Santana, former elected Rio Hondo School Board Trustee and Harvard University graduate for City Council District 2, and Aida Macedo, attorney and Whittier small business owner for City Council District 4. All three are committed to Saving our Tree Canopy AND to working with Whittier's Businesses and Residents for our City to thrive.



SUBJECT: Request Expediting Conflict of Interest Investigation of Whittier Mayor Joe Vinatieri,
FPPC Case No: 2024-00927

Dear Chairman Silver and Commissioners:

The City of Whittier will hold an election on April 14, 2026 for Mayor and Council Members in Districts 2 and 4. Mayor Joe Vinatieri, an incumbent on the Whittier City Council for the past 20 years and citywide Mayor since 2016, is again seeking re-election. A cloud of controversy hangs over his re-election campaign due to the FPPC's ongoing investigation of a sworn complaint allegation of Conflict of Interest against him, Case No: 2024-00927. I filed that sworn complaint on June 17, 2024; the FPPC Enforcement Division opened the investigation on Sept. 10, 2024 (copy of notification and wording of sworn complaint attached).

The sworn complaint alleges that Mayor Vinatieri did not recuse himself from voting on two City Council agenda items on the controversial, \$20+ million Uptown Whittier Greenleaf Promenade Plan despite owning a business located within the project area. The background and evidence substantiating the allegation is included in the 2 ½ pages of the attached sworn complaint. Upon review, please note that the complaint was filed a day prior to the Whittier City Council's final meeting/study session regarding this issue on June 18, 2024. The City Council voted 3-1 to proceed with the Promenade Plan that calls for removal of ALL the trees on three blocks of Greenleaf Av in the heart of Uptown. The Whittier City Council's initial vote on Dec. 12, 2023 to proceed with that Promenade design option triggered public outrage regarding their decision to remove the mature, shady tree canopy. As described in the complaint, "the strength of the public outcry is reflected by 4,010+ signatures on a petition to Save our Trees in Uptown Whittier..." Public outrage has intensified over the past two years as reflected by 8,079 signatures currently on that petition, and a lawsuit filed by The Whittier Conservancy (case number: 24STCP03966). That lawsuit is scheduled for trial next month in L.A. County Superior Court.

On several occasions since the FPPC opened this case, I called and emailed the assigned Political Reform Consultant to ask for an update, including inquiring about sending a letter to the Investigation team in hopes of increasing the pace of the investigation. I was told that it would have no impact. As Commissioners, I am bringing the timing of this matter to your personal attention because, in my experience when serving as L.A. County Registrar-Recorder/County Clerk, when highly-sensitive issues arose, I was occasionally frustrated that staff had not brought the matter to my attention for resolution before it erupted.

WORDING OF FPPC SWORN COMPLAINT AGAINST JOE VINATIERI

This complaint alleges a violation of FPPC conflict of interest provisions by Joe Vinatieri, Mayor of the City of Whittier, CA. On August 22, 2023, Mayor Vinatieri participated in a vote of the City Council that he should have recused himself from voting on. His “aye” vote that day was on an agenda item for the controversial Uptown Streetscape and Greenleaf Promenade plan to expand the geographic scope of the project’s size by 51% in the central core of Whittier’s Uptown business district¹. The controversy currently raging in Whittier is described below under “Background”, including Mayor Vinatieri’s pivotal role.

In June 2021, Mayor Joe Vinatieri opened Auntie’s restaurant located within the area designated for the Uptown Streetscape Greenleaf Promenade plan in the central business district of Whittier. For several years prior to that date, the City Council, with Mayor Joe Vinatieri’s participation, held discussions at multiple meetings about spending millions of dollars to revitalize Uptown Whittier, with the goal of bringing in more money to businesses in the Uptown core. Those discussions evolved from a proposed expenditure of \$3.5-\$3.8 million for infrastructure improvements for a one block area of Greenleaf Av in 2019 called the Gardens of Uptown Whittier, to a three-block area of Greenleaf Av early in 2021 called the Uptown Streetscape Greenleaf Promenade plan encompassing the area of Auntie’s restaurant located at 6506 Greenleaf Av. The City’s cost estimate for the Uptown Streetscape Greenleaf Promenade plan is \$20 million, due to expansion of the project and the addition of a new water main on those three blocks of Greenleaf Av (cost of new water main is estimated at \$6-8 million.)

Between June 2021 and August 22, 2023, the City Council conducted several meetings where the agendas included minor aspects of the Greenleaf Promenade plan in which Joe Vinatieri recused himself, stating he has a conflict of interest due to his business located within that area, Auntie’s restaurant. But on August 22, 2023, Item 12K entitled “Greenleaf Promenade Design Services” was placed on the Consent Calendar described as an \$84,500 amendment to SWA project consultants to increase the project’s design. At that meeting, Mayor Joe Vinatieri asked if any member of the Council wished to recuse themselves on any of the Consent Calendar items or pull any of those items for discussion. No one did. The City Council, including Mayor Vinatieri, voted in favor. The city manager in consultation with the mayor makes the determination about which items are placed on the Consent Calendar for City Council meetings.

Background: Public outcry over the Greenleaf Promenade plan exploded in January 2024 after residents found out that the City Council voted on Dec 12, 2023 to approve an “amended” version of the Uptown Streetscape Greenleaf Promenade plan². This version involves chopping down ALL the trees at once on those three blocks of Greenleaf Av, including the iconic canopy of ficus trees, instead of gradually phasing-in tree removal and replacement to retain the tree

canopy as described in Whittier's existing ordinances (Uptown Specific Plan, 2008 & rev. 2014, and Tree Protection Ordinance, 2016). For years, Mayor Joe Vinatieri has publicly expressed his extreme dislike of ficus trees and his desire to remove them due to roots uplifting sidewalks.

Because of public outrage at the impending tree massacre, first expressed at the Jan. 23, 2024 City Council meeting following the Dec. 12, 2023 vote, the City Council put the Greenleaf Promenade Project on "pause" to further study the issue. That "pause" has now extended for six months, encompassing two special City Council meetings/study sessions devoted solely to this issue, held on Feb. 20 and April 30, 2024, with a third (and expected final) city council meeting/study session on this issue scheduled for June 18, 2024.³

During the past six months, residents have expressed their support for repairing and replacing uplifted sidewalks and other improvements to the City's infrastructure, while vociferously opposing removal of Uptown Whittier's iconic, shady canopy of ficus trees, clearly stating these goals are NOT mutually exclusive. Residents are advocating for a re-design of the Uptown Streetscape Greenleaf Promenade plan to meet both goals. The strength of the public outcry is reflected by 4,010+ signatures, and growing daily, on a petition to Save our Trees in Uptown Whittier⁴, overflowing crowds at the special City Council meetings on Feb. 20 and April 30, hundreds of letters sent to the City Council, and a Rally to Save Our Trees⁵. Media coverage of this tree controversy includes widespread TV and print, including the L A Times.⁶

Mayor Vinatieri has publicly stated for years his desire to rid the City of ficus trees. As the long-time mayor and only citywide elected official, he is influential in shaping opinions and votes of other Council members. He is a driving force and key advocate for the current design of the Uptown Streetscape Greenleaf Promenade plan that calls for removal of ALL the trees on the designated three blocks of Greenleaf Av, including 83 ficus trees, replacing them with much smaller trees. Such action would eliminate historic Uptown Whittier's most recognizable and distinctive feature, the magnificent tree canopy.

While recusing himself from many City Council meeting discussions and votes on this project, Mayor Vinatieri also voted “aye” when he should have recused himself regarding Item 12G on the Consent Calendar at the City Council meeting on Feb. 27, 2024. Although the title of that agenda item, FY 2024-25 Federal Community Benefit Project Requests, did not specifically mention the Greenleaf Promenade plan, the one-page staff report attached to the item clarifies the request encompasses “the Greenleaf Av Water Project (Part of Streetscape Project)”.

Most recently, during the Public Comment period at the June 11, 2024 City Council meeting, many Whittier residents spoke passionately to advocate saving the existing ficus tree canopy in Uptown, including a speaker who expressed criticism of Mayor Vinatieri’s involvement despite supposedly recusing himself.ⁱ At the very end of that City Council meeting, Mayor Vinatieri rebuked public speakers stating he follows the law and has not exhibited a conflict of interest. The examples cited above refute his statement and form the basis for this FPPC conflict of interest complaint.
